Students need to bring, and carry on their own, the following items:

- Comfortable clothing to sit and move in
- Layers for temperature changes, it will be very cold at times
- Personal bathroom items
- Extra blanket/sleeping bag if desired (standard bedding and a towel will be provided)
- Flashlight (optional)
- Closed toe shoes for uneven terrain
- Lip balm and sunscreen

### Medication:

Minors who take medication will need to arrange drop off and administration details with your school's/organization's administration/health office or an AIT representative upon arrival. During the trip, a school representative or, if contracted, a medical professional will be disbursing medication as prescribed. All It Takes will not be responsible for medication.

### Participants are not allowed to bring the following:

- Inappropriate Clothing, Weapons, or any Dangerous Items, if your school/organization doesn't allow it, neither do we.
- Medication/drugs not prescribed by a physician and held by school/organization staff.
- **Phones:** Phones will not be in participant possession during the program. Upon arrival all phones and electronics will be collected by AIT and locked away for the duration of the program. All phones will be off limits from arrival to departure unless indicated as a part of the program. Participants who need to reach their parents/guardians will be supported by AIT staff. Parents/guardians that need to reach participants will be able to contact us. \*All It Takes/Canyon Creek will not be responsible for electronics that are lost, broken or confiscated from participants not following this rule. If you need to reach your participant during camp, please call (661)-724-9184.
- **Electronic devices.** No electronics of any kind can be used during programming or overnight. This includes but is not limited to tablets, iPods, smart watches, and any others not noted here.

### Supervision:

All participants are to be respectful and compliant with all adults at the program. Staff will always be available to participants should a concern arise. Should a participant feel the need to contact home, AIT staff will support them.

AIT/Canyon Creek staff reserve the right to search any personal items of participants should it be determined necessary.

Students will be staying in cabins without an adult stationed in the rooms. Night security will patrol throughout the night and All It Takes staff and venue staff will be accessible to all students at all times. This training is for students operating at higher levels of leadership capacity and many have mentored and ran a cabin of middle students on their own. We believe that these students can handle the responsibility of being in a cabin without direct supervision.

### Participant Information and Agreements

I agree to abide by all rules and agree to listen to Staff and Mentors direction and comments during the program. If I have a problem with something or someone, I will respectfully request to speak to a staff member. If my concerns are urgent, I will politely let any adult know that I need immediate help and my needs will be addressed immediately. All mentors, All It Takes staff and Canyon Creek staff are committed to do All It Takes to ensure each participant is physically and emotionally taken care of and empowered to achieve their personal best while supporting their peers to do the same.

#### Agreements:

- I will be in assigned locations at all times.
- I will stay out of the cabins during workshops and activities.
- I will leave my phone and other devices at home or turn it over to an AIT staff member upon collection during arrival.
- I will stay within camp boundaries at all times.
- I will be respectful to all people at all times.
- I will not use profanity or any other verbal or physical form of abuse. This includes name-calling and teasing.
- I will not bring nor use any form of tobacco, alcohol or other drugs. I will report such use by anyone attending, to a mentor or staff member.
- I understand that there are NO INNOCENT BYSTANDERS during this training. If I am in a group where a rule is being broken or safety is compromised and I choose to remain in the group I will be subject to full consequences of the rule broken.
- I will wear appropriate clothing at all times. Activities during the program will involve body movement that may make certain clothing impossible to wear modestly.
- I will behave appropriately and safely inside my cabin, this includes staying in my cabin when instructed, respecting others space, cleaning up after myself, and if a problem arises I will immediately reach out to a staff member.

**PARTICIPANT:** I understand that I am 100% accountable for my actions and choices. I understand all the rules and expectations and agree to comply with them. I recognize that I am being offered a unique opportunity to have a great time while learning new things about myself that are geared to make a positive difference in my life and the lives of others. I know that I have complete control over how successful this program will be for me and agree to be open- minded and willing to trust the process of the program to do All It Takes to embrace all

### Acknowledgement of Responsibility

**EVENT: Youth Leadership Certification Summit January 28-30, 2022**
